TERMS AND CONDITIONS

1. Introduction

- 1.1 This document sets out the terms and conditions ("**Terms**") that apply to participate in the Ronaldinho signed jersey giveaway via Instagram ("**Competition**").

The Promoter reserves the right to change these Terms at any time and to communicate the changes to Entrants by updating these Terms on Instagram.
- 1.3 By entering this Competition, all Entrants will be deemed to have accepted and agreed to be bound by these Terms.

2. Participation

- 2.1 To participate in the Competition Entrants must be:
 - a) aged 18 or over on the Opening Date; and
 - b) a resident in the United Kingdom, (each an "Entrant" and together, the "Entrants").
- 2.2 To take part in the Competition:
